Secretary's Report - Don Smart

<u>Treasurer's Report</u> – Terri Wirtz

- Beginning account balance as of last rally April 5, 2019 was \$1,240.91. Ending balance as of October 3, 2019 is \$1,142.07.
- Spring rally deficit was \$54.80.
- \$140 has been collected for the fall rally, with no expenses paid so far.
- Dues collected for 2019 since last April is \$35.00.
- Dues collected for 2020 is \$25.00.
- Dues collected for 2021 is \$10.00.
- T-shirt sales at the Fall Rally have totaled \$104.00.
- Ending balance (before current rally expenses) is \$1,391.18.
- There are 28 Fall Rally attendees (13 rigs).

- Dues paid in advance are set aside in the treasury to be used for expenses of the appropriate year.
