## STANDING RULES

- 1. In order to provide continuity, terms of office of the elected officers will be staggered by having the president and secretary elected in even-numbered years, and the vice president and treasurer in the odd-numbered years.
- 2. The duties of the president, vice president, secretary, and treasurer shall be as specified in the various Chapter Officer's Handbooks in effect at the time of passage of this article for the respective positions.

## 3. Chapter Rallies:

- a. Rallies shall be held within the borders of North Carolina or South Carolina unless otherwise approved by the Board. The Spring Rally shall be held in April on the East side of North Carolina/South Carolina and Fall Rally shall be held September or October on the West side of North Carolina/South Carolina. Rallies may be staged along the borders of Virginia, Georgia or Tennessee with prior Board approval.
- b. No rally shall be scheduled to conflict with any National function, such as Escapade, if such function is within 1,200 miles.
- c. No rally shall be scheduled to conflict with All Chapter Rally East (ACRE).

## 4. Chapter newsletter:

- a. The Chapter newsletter editor shall be appointed by the president. The editor shall perform duties as specified in the Editor's Handbook provided by Escapees RV Club.
- b. A Chapter newsletter shall be published and emailed to each paid chapter member no fewer than four times per year, to be sent throughout the year. The newsletter editor shall also maintain a mailing list consisting of both members and non-members for the purpose of notification of events and distribution of newsletters.
- c. The name of the chapter newsletter shall be "The Carolina Rovers".
- d. The Newsletter Editor shall maintain a digital archive and backup of the Chapter Website, which shall be deemed the Chapter historical records.
- 5. No smoking shall be permitted inside any room where a chapter function is held if such function is open to all members.
- 6. Chapter monies, including dues and rally fees, shall be expended solely for the benefit of the membership. No monies may be used for any charitable cause.
- 7. If a rally is funded by Chapter monies, visitors are to be charged \$5.00 per person unless they join the Chapter during the rally in which case the rally fee is waived.
- 8. The Carolina Rovers, Chapter 29, is a non-political, non-sectarian social club for the benefit of members who share the common interest of RV travel. Members shall refrain from any political, religious or economic discussions at Chapter events.

The following banner shall be included in all Rally Notices as a reminder to all members: "No Politics Please!! Only Gratitude, Appreciation, Pride and Fellowship".

9. To be in compliance with Bylaws, Article VII, the annual dues is set at \$5.00 per rig.

## 10. Miscellaneous:

- a. Escapade representatives of the Chapter shall serve on a voluntary basis.
- b. The following shall be the only official logo of this chapter. It may be used on an item offered for resale only with prior approval of two elected officers.
